Municipal Ordinance No. 2022 - 17

AN ORDINANCE UPGRADING OF NURSE I AND NURSE II SALARY GRADE IN THE PLANTILLA OF PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF OPOL

WHEREAS, Section 16 of the Local Government Code expressly states that within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;


WHEREAS, Section 325 (f) of the Code provides that the use of the provincial, city, and municipal funds shall be subject to the limitation that no changes in designation or nomenclature of positions resulting in a promotion or demotion in rank or increase or decrease in compensation shall be allowed, except when the position is actually vacant, and the filling of such positions shall be strictly made in accordance with the civil service law, rules and regulations;

WHEREAS, Section 32 of R.A. No. 9173, otherwise known as the "The Philippine Nursing Act of 2002, provides a minimum base pay of not lower than Salary Grade (SG) – 15 for Nurses working in the public health institutions;

WHEREAS, the Department of Budget and Management, through DBM Local Budget Circular No. 2020-4 dated July 17, 2020, prescribed the rules and regulations on the upgrading on the entry-level of Nurse positions to SG-15 as well as to highlight the administrative procedures in view of the consequential modification in the position attributes of the Nurse items;

WHEREAS, in an urgent letter dated July 21, 2022, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue an Ordinance upgrading the Salary Grade of Nurse I and Nurse II in the Plantilla of Personnel of the Municipality of Opol;

WHEREFORE, on motion presented by Hon. Rhally Mae G. Piit and duly seconded by Hon. Roland B. Alfeche; it was



RESOLVED, as the body hereby resolves, to enact:

**AN ORDINANCE UPGRADING OF NURSE I AND NURSE II SALARY GRADE IN THE
PLANTILLA OF PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF OPOL**

Section 1. Current Position Titles and Salary Grade – The current Position Titles in the Plantilla of Personnel are Nurse I with Salary Grade (SG) of 11 and Nurse II with Salary Grade (SG) of 15.

Section 2. Upgrading of Nurse I and Nurse II Positions– The Salary Grade (SG) of Nurse I and Nurse II positions shall be upgraded by four (4) SGs and one (1) SG, respectively, as shown below:

Position Title	Salary Grade	
	From	To (Per Office of the President Directive dated June 1, 2021)
Nurse I	11	15
Nurse II	15	16

Section 3. Salary Rate – The Salary Rate Nurse I and Nurse II positions shall be as follows:

Position Title	Salary Rate (LBC No. 143) 3rd Tranche
Nurse I	PhP29,832.00
Nurse II	PhP32,428.00


Section 4. Separability Clause – Should any provision or section of this Ordinance or any part thereof be declared invalid, the other provisions or sections, insofar as they are separable from the invalid ones, shall remain in full force and effect.

Section 5. Effectivity – This Ordinance shall take effect immediately after a copy hereof is posted in a bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places.

RESOLUTION NO. 316-2023

RESOLUTION DECLARING AS VALID MUNICIPAL ORDINANCE NO. 2022-17 OF OPOL, MISAMIS ORIENTAL ENTITLED "AN ORDINANCE UPGRADING OF NURSE I AND NURSE II SALARY GRADE IN THE PLANTILLA OF PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF OPOL."

WHEREAS, the Sangguniang Bayan of Opol has submitted Ordinance No. 2022-17 to the Sangguniang Panlalawigan for review;

WHEREAS, all the necessary documents required under the Local Government Code of 1991 and other existing laws have been complied with and submitted to the Sangguniang Panlalawigan for ready reference;

WHEREAS, the Ordinance was referred to the Local Finance Committee through the Provincial Budget Office for comment and recommendation;

WHEREAS, Section 76 of the Local Government Code of 1991 explicitly provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 447 (a) (1) (viii) of the Code empowers the Sangguniang Bayan to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

WHEREAS, Section 468 (a) (1) (i) of the Code mandates the Sangguniang Panlalawigan, as the legislative body of the Province, to review all Ordinances approved by the Sanggunians of component Cities and Municipalities and Executive Orders issued by the Mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor;

WHEREAS, the Local Finance Committee, through the Provincial Budget Office, has recommended the approval of Municipal Ordinance No. 2022-17 of Opol, Misamis Oriental, subject however, to the conditions imposed in its 1st Endorsement dated 5 January 2023, which shall form an integral part of this Resolution and hereto attached;


WHEREAS, the Committee on Provincial Organization, Structure and Operation has reviewed Municipal Ordinance No. 2022-17 and found it to be within the scope of the prescribed powers of the Sangguniang Bayan of Opol, Misamis Oriental;

WHEREAS, the Sangguniang Panlalawigan of Misamis Oriental concurs with the findings and recommendations of the Committee;
