Resolution No. 2022 - 156

A Resolution Adopting and Approving Resolution No. 2022-03 of the Disaster Risk Reduction and Management Council (DRRMC) of Opol, specifically the Contingency Plan Management Council Plan on Flood for CY 2023- 2025

WHEREAS, Section 12 (a) of the Philippine Disaster Risk Reduction and Management Act of 2010 expressly states that there shall be established an Local Disaster Risk Reduction and Management Office (LDRRMO) in every province, city and municipality, and a Barangay Disaster Risk Reduction and Management Committee (BDRRMC) in every barangay which shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction;

WHEREAS, Section 12 (c) (1) and Section 12 (c) (6) of the same Act mandate the municipal DRRMO's or BDRRMCs to design, program, and coordinate disaster risk reduction and management activities consistent with the National Council's standards and guidelines and to formulate and implement a comprehensive and integrated Local Disaster Risk Reduction and Management Plan (LDRRMP) in accordance with the national, regional and provincial framework, and policies on disaster risk reduction in close coordination with the local development councils (LDCs), respectively;

WHEREAS, Section 12 (c) (7) of the Act also mandates the municipal DRRMO's or BDRRMCs to prepare and submit to the local sanggunian through the Local Disaster Risk Reduction Management Council (LDRRMC) and the Local Development Council (LDC) the annual LDRRMO Plan and budget, the proposed programming of the LDRRMF, other dedicated disaster risk reduction and management resources, and other regular funding source/s and budgetary support of the LDRRMO/BDRRMC;

WHEREAS, on August 17, 2022, the Local Disaster Risk Reduction Management Council (LDRRMC) conducted its full council meeting and reconstituted the members of the LDRRMC;

WHEREAS, one of the agenda of the LDRRMC included the Community Based Disaster Risk Reduction Management (CBDRRM) Plan for the fourteen (14) barangays, the respective risk assessment maps of the barangays and the Programs, Projects and Activities (PPAs) of the LDRRM Fund Investment Plan for the General Fund and Special Accounts (Opol Community College, Public Market, Motorpool and Slaughterhouse);

WHEREAS, in an urgent letter dated September 1, 2022, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to adopt and approve the Contingency Plan Management Council Plan on Flood for CY 2023- 2025;

WHEREFORE, on motion presented by Hon. Roland B. Alfeche and duly seconded by Hon. Palmero F. Ebonia; it was

RESOLVED, AS THE BODY HEREBY RESOLVES, to approve the Resolution Adopting and Approving Resolution No. 2022-03 of the Disaster Risk Reduction and Management Council (DRRMC) of Opol, specifically the Contingency Plan Management Council Plan on Flood for CY 2023-2025.
