Resolution No. 2022- 200

A Resolution Authorizing the Local Chief Executive, Mayor Jayfrancis D. Bago, to enter into a Memorandum of Agreement with the Department of Labor and Employment Regional Office 10, represented by its Regional Director, Albert E. Gutib, to engage Government Internship Program (GIP) Interns in the Municipality of Opol, Misamis Oriental

WHEREAS, Section 16 of the Local Government Code expressly states that the local government units shall, within their respective territorial jurisdictions, ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 444 (b) (1) (vi) of the same Code states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated October 14, 2022, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to authorize him to enter into a Memorandum of Agreement with the Department of Labor and Employment Regional Office 10, represented by its Regional Director, Albert E. Gutib, for the engagement of Government Internship Program (GIP) Interns in the Municipality of Opol, Misamis Oriental;

WHEREFORE, on motion presented by Hon. Rhally Mae G. Piit and duly seconded by Hon. Palmero F. Ebonia; it was
