**Resolution No. 2022- 209**

**A Resolution Authorizing the Local Chief Executive, Mayor Jayfrancis D. Bago, to enter into a Memorandum of Agreement with the Department of Agriculture Regional Field Office 10 (DA-RFO 10) represented by the OIC Regional Office Director, Carlene C. Collado, CPA, for the Farm Diversification and Livelihood Project, otherwise known as the Balik Probinsya, Bagong Pag-Asa Program (BP2)**

**WHEREAS**, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the same Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

**WHEREAS**, pursuant to Section 4 of the Executive Order No. 114, otherwise known as the Balik Probinsya, Bagong Pag-Asa Program (BP2), the BP2 Program is established as a national program of the government, and adopted as a continuing strategy to drive inclusive and balanced urban and rural development, ensure rural prosperity and complement initiatives towards attaining resilient and sustainable communities;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code likewise states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated October 14, 2022, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to authorize him to enter into a Memorandum of Agreement with the Department of Agriculture, Regional Field Office 10 (DA-RFO 10), represented by its OIC Regional Office Director, Carlene C. Collado, CPA, for the Farm Diversification and Livelihood Project, otherwise known as the Balik Probinsya, Bagong Pag-Asa Program (BP2);

**WHEREAS**, the Local Government Unit of Opol desires to help its constituents by providing farm diversification and livelihood development programs to its farmer and fisherfolk beneficiaries;



**WHEREAS**, the Local Government Unit of Opol and Department of Agriculture, Regional Field Office 10 shall spearhead the Farm Diversification and Livelihood Project in coordination with the National Home Mortgage Authority and the Department of Social Welfare and Development to validate the principal beneficiaries of the Balik Probinsya, Bagong Pag-Asa Program (BP2);

**WHEREFORE**, on motion presented by Hon. Danilo O. Daroy and duly seconded by Hon. Roland B. Alfeche; it was

**RESOLVED, AS IT IS HEREBY RESOLVED**, to approve the Resolution Authorizing the Local Chief Executive, Mayor Jayfrancis D. Bago, to enter into a Memorandum of Agreement with the Department of Agriculture Regional Field Office 10 (DA-RFO 10) represented by the OIC Regional Office Director, Carlene C. Collado, CPA, for the Farm Diversification and Livelihood Project, otherwise known as the Balik Probinsya, Bagong Pag-Asa Program (BP2).
