Resolution No. 2023-003

A Resolution to request Funding from the Department of Health-Center for Health Development (DOH-CHD) - Northern Mindanao, through its Regional Director, Dr. Jose R. Llacuna, Jr., for the establishment of a Super Health Center in Opol, Misamis Oriental

WHEREAS, Section 16 of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 (a) of the Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, pursuant to Section 17 (b) (2) (iii) of the Code, local government units shall provide basic services and facilities such as, but are not limited to, health services which include the implementation of programs and projects on primary health care, maternal and child care, and communicable and non-communicable disease control services, access to secondary and tertiary health services; purchase of medicines, medical supplies, and equipment needed to carry out the services herein enumerated;

WHEREAS, in an urgent letter dated December 29, 2022, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution to request funding from the Department of Health –Center for Health Development (DOH-CHD) - Northern Mindanao, through its Regional Director, Dr. Jose R. Llacuna, Jr., for the establishment of a Super Health Center in Opol, Misamis Oriental;

WHEREAS, the national government, through the Department of Health –Center for Health Development (DOH-CHD), had launched a nationwide Super Health Center which provides services such as, but not limited to, data management, out-patient, birthing, isolation, and diagnostic services, including x-ray and ultrasound services, pharmacy, eye, ear nose, and throat (EENT) services, and ambulatory surgical unit;

WHEREFORE, on motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was


