**Resolution No. 2023-004**

**A Resolution Confirming the Commitment of the Municipality of Opol to proceed with the Farm-to-Market Road (FMR) Project in Barangay Bagoceboc, as validated by the Department of Agriculture, particularly the Road Concreting of Barangay Bagoceboc FMR in Barangay Bagoceboc, Opol, Misamis Oriental, with the estimated length of one (1) kilometer, amounting to Twelve Million Pesos (PhP12,000,000.00), more or less**

**WHEREAS**, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the same Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

**WHEREAS**, pursuant to Section 444 (b) (4) (i) of the Code, the Municipal Mayor shall ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the municipality and the province;

**WHEREAS**, in an urgent letter dated December 29, 2022, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution confirming the commitment of the Municipality of Opol to proceed with the Farm-to-Market Road (FMR) Project in Barangay Bagoceboc, Opol, Misamis Oriental, particularly the Road Concreting of Barangay Bagoceboc FMR which was already validated by the Department of Agriculture and had an estimated length of one (1) kilometer amounting to Twelve Million Pesos (PhP12,000,000.00), more or less;

**WHEREAS**, the Municipality of Opol strongly believed that its partnership with the Department of Agriculture in the construction of various Farm-to-Market-Roads (FMRs) will empower the farmers and fisher folks of Opol in creating more opportunities for agribusiness, tourism, public interventions and investments, and other support services that promote agricultural productivity and development;

**WHEREFORE**, on motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Palmero F. Ebonia; it was

**RESOLVED, AS THE BODY HEREBY RESOLVES**, to approve the Resolution Confirming the Commitment of the Municipality of Opol to proceed with the Farm-to-Market Road (FMR) Project in Barangay Bagoceboc, as validated by the Department of Agriculture, particularly the Road Concreting of Barangay Bagoceboc FMR in Barangay Bagoceboc, Opol, Misamis Oriental, with the estimated length of one (1) kilometer, amounting to Twelve Million Pesos (PhP12,000,000.00), more or less.
