**Resolution No. 2023-008**

**A Resolution to request Funding from the Office of Senator Ronald M. dela Rosa for Road Concreting and Repair of Malanang Road in Barangay Malanang, Opol, Misamis Oriental in the amount of Twenty Million Pesos (Php20,000,000.00)**

**WHEREAS**, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the same Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

**WHEREAS**, pursuant to Section 444 (b) (4) (i) of the Code, the Municipal Mayor shall ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the municipality and the province;

**WHEREAS**, in an urgent letter dated December 29, 2022, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution to request funding amounting to Twenty Million Pesos (Php20,000,000.00) from the Office of Senator Ronald M. dela Rosa for Road Concreting and Repair of Malanang Road in Barangay Malanang, Opol, Misamis Oriental;

**WHEREAS**, the Municipality of Opol aimed to construct more Farm-to-Market Roads (FMRs) in the hinterland barangays of Opol that will empower the farmers in creating more opportunities for agribusiness, tourism, public interventions and investments, and other support services that promote agricultural productivity and development;

**WHEREFORE**, on motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Jeffrey P. Pusan; it was


**RESOLVED, AS THE BODY HEREBY RESOLVES**, to approve the Resolution to request Funding from the Office of Senator Ronald M. dela Rosa for Road Concreting and Repair of Malanang Road in Barangay Malanang, Opol, Misamis Oriental in the amount of Twenty Million Pesos (Php20,000,000.00).
