**Resolution No. 2023-009**

**A Resolution Declaring as Valid Barangay Resolution No. 06, Series of 2022 of Barangay Igpit, Opol, Misamis Oriental entitled "A Resolution Endorsing the Adoption and Approval of Unexpended Balance P78,010.00 from 2021 Calamity Fund and Amending the Local Disaster Risk Reduction Management Fund Investment Plan for 2022 of Igpit Barangay Council all under the 5% Calamity Fund"**

**WHEREAS**, the Barangay Igpit of Opol, Misamis Oriental has submitted the Barangay Resolution No. 06, Series of 2022 to the Sangguniang Bayan of Opol for review;

**WHEREAS**, Barangay Resolution No. 06, Series of 2022 endorses the adoption and approval of Unexpended Balance of Php78,010.00 from the 2021 Calamity Fund and amends the Local Disaster Risk Reduction Management Fund Investment Plan for CY 2022 of Igpit Barangay Council both under the 5% Calamity Fund;

**WHEREAS**, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

**WHEREAS**, the Municipal Budget Office, through the Municipal Budget Officer, has reviewed Barangay Resolution No. 06, Series of 2022 and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Igpit, Opol, Misamis Oriental subject however to the condition in its Letter dated November 17, 2022, stating that all disbursements of the item specified are subject to the conditions of all accounting and auditing rules and regulations and to the availability of funds;

**WHEREAS**, the Committee on Finance, Budget and Appropriation has recommended the approval of the Barangay Resolution No. 06, Series of 2022 of Barangay Igpit, Opol, Misamis Oriental;

**WHEREAS**, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;

**WHEREFORE**, on motion of Hon. Rhally Mae G. Piit and duly seconded by Hon. Palmero F. Ebonia; it was
