**Resolution No. 2023-011**

**A Resolution Declaring as Valid Barangay Appropriation Ordinance No. 08, Series of 2022 of Barangay Igpit, Opol, Misamis Oriental entitled "An Ordinance Authorizing the Realignment of Unexpended Funds from 2022 Annual Budget PS in the total amount of P375,000.00 to Year-End Bonus, Cash Gift and Productivity Enhancement Incentive under PS of the General Fund"**

**WHEREAS**, the Barangay Igpit of Opol, Misamis Oriental has submitted the Barangay Appropriation Ordinance No. 08, Series of 2022 to the Sangguniang Bayan of Opol for review;

**WHEREAS**, Barangay Appropriation Ordinance No. 08, Series of 2022 realigns the Unexpended Funds of PhP375,000.00 to the Year-End Bonus, Cash Gift and Productivity Enhancement Incentive both under the Personal Services of the Annual Budget for CY 2022;

**WHEREAS**, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

**WHEREAS**, the Municipal Budget Office, through the Municipal Budget Officer, has reviewed Barangay Appropriation Ordinance No. 08, Series of 2022 and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Igpit, Opol, Misamis Oriental subject however to the condition in its Letter dated November 24, 2022, stating that all disbursements of the item specified are subject to the conditions of all accounting and auditing rules and regulations and to the availability of funds;

**WHEREAS**, the Committee on Finance, Budget and Appropriation has recommended the approval of the Barangay Appropriation Ordinance No. 08, Series of 2022 of Barangay Igpit, Opol, Misamis Oriental;

**WHEREAS**, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;


