**Resolution No. 2023-013**

**A Resolution Declaring as Valid Barangay Appropriation Ordinance No. 07, Series of 2022 of Barangay Barra, Opol, Misamis Oriental entitled "An Ordinance Realigning the amount of P27,300.00 from Unexpended Balances on AB-2022 of Barangay Barra from PS, MOOE and Capital Outlay to Purchase of Rice for Barangay Workers"**

**WHEREAS**, the Barangay Barra of Opol, Misamis Oriental has submitted the Barangay Appropriation Ordinance No. 07, Series of 2022 to the Sangguniang Bayan of Opol for review;

**WHEREAS**, Barangay Appropriation Ordinance No. 07, Series of 2022 realigns the Unexpended Balances of PhP27,300.00 from the Personal Services, Maintenance and Other Operating Expenses (MOOE), and Capital Outlay under the Annual Budget for CY 2022 to the Purchase of Rice for Barangay Workers;

**WHEREAS**, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

**WHEREAS**, the Municipal Budget Office, through the Municipal Budget Officer, has reviewed Barangay Appropriation Ordinance No. 07, Series of 2022 and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Barra, Opol, Misamis Oriental subject however to the condition in its Letter dated November 23, 2022, stating that all disbursements of the item specified are subject to the conditions of all accounting and auditing rules and regulations and to the availability of funds;

**WHEREAS**, the Committee on Finance, Budget and Appropriation has recommended the approval of the Barangay Appropriation Ordinance No. 07, Series of 2022 of Barangay Barra, Opol, Misamis Oriental;

**WHEREAS**, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;

**WHEREFORE**, on motion of Hon. Rhally Mae G. Piit and duly seconded by Hon. Eliezer A. Vacalares, Jr.; it was


