**Resolution No. 2023-015**

**A Resolution Electing Hon. Glee A. Jacalan and Hon. Chizarina M. Ortigoza as Presiding Officer Pro Tempore and Presiding Officer Assistant Pro Tempore, respectively**

**WHEREAS**, Section 48 of the Local Government Code provides that local legislative power shall be exercised by the sangguniang panlalawigan for the province; the sangguniang panlungsod for the city; the sangguniang bayan for the municipality; and the sangguniang barangay for the barangay;

**WHEREAS**, Section 49 of the Code states the following:

(a) The vice-governor shall be the presiding officer of the sangguniang panlalawigan; the city vice-mayor, of the sangguniang panlungsod; the municipal vice-mayor, of the sangguniang bayan; and the punong barangay, of the sangguniang barangay; and

(b) In the event of the inability of the regular presiding officer to preside at a sanggunian session, the members present and constituting a quorum shall elect from among themselves a temporary presiding officer.

**WHEREAS**, pursuant to Section 50 (b) (6) of the Code, the rules of procedure shall provide such other rules as the sanggunian may adopt;

**WHEREAS**, Hon. Glee A. Jacalan nominated Hon. Chizarina M. Ortigoza as Presiding Officer Pro Tempore, while likewise Hon. Glee A. Jacalan was nominated by Hon. Chizarina M. Ortigoza to the said position;

**WHEREAS**, majority of the Honorable Members of the Sangguniang Bayan voted Hon. Glee A. Jacalan as the Presiding Officer Pro Tempore, and Hon. Chizarina M. Ortigoza as the Presiding Officer Assistant Pro Tempore;

**WHEREAS**, in the absence of both the Presiding Officer Pro Tempore and Presiding Officer Assistant Pro Tempore, the Honorable Members of the Sangguniang Bayan who are present and constituting a quorum shall elect among themselves a Presiding Officer Pro Tempore;

**WHEREFORE**, on motion of Hon. Chizarina M. Ortigoza and duly seconded by Hon. Roland B. Alfeche; it was

**RESOLVED, AS IT IS HEREBY RESOLVED**, to approve the Resolution Electing Hon. Glee A. Jacalan and Hon. Chizarina M. Ortigoza as Presiding Officer Pro Tempore and Presiding Officer Assistant Pro Tempore, respectively.
