**Resolution No. 2023- 17**

**A Resolution Declaring as Operative Barangay Appropriation Ordinance No. 03, Series of 2022 of Barangay Luyongbonbon, Opol, Misamis Oriental entitled “An Ordinance for the Reversion of Unexpended Amount of Php58,529.00 from Various Identified Programs of 70% Pre-Disaster Preparedness of Calamity Fund to Procurement of Food and Non-Food Items all under the 2022 5% Calamity Fund”**

**WHEREAS**, the Barangay Luyongbonbon of Opol, Misamis Oriental has submitted the Barangay Appropriation Ordinance No. 03, Series of 2022 to the Sangguniang Bayan of Opol for review;

**WHEREAS**, Barangay Appropriation Ordinance No. 03, Series of 2022 reverts the amount of Fifty Eight Thousand Five Hundred Twenty Nine Pesos (Php58,529.00) from the Various Identified Programs under the 70% Pre-disaster Preparedness of Calamity Fund to the Procurement of Food and Non-Food Items all under the 5% Calamity Fund for CY 2022;

**WHEREAS**, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

**WHEREAS**, the Municipal Budget Office, through the Municipal Budget Officer, has reviewed Barangay Appropriation Ordinance No. 03, Series of 2022 and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Luyongbonbon, Opol, Misamis Oriental subject however to the condition in its Letter dated December 21, 2022, stating that all disbursements of the item specified are subject to the conditions of all accounting and auditing rules and regulations and to the availability of funds;

**WHEREAS**, the Committee on Finance, Budget and Appropriation has recommended the approval of the Barangay Appropriation Ordinance No. 03, Series of 2022 of Barangay Luyongbonbon, Opol, Misamis Oriental;


**WHEREAS**, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;

**WHEREFORE**, on motion of Hon. Rhally Mae G. Piit and duly seconded by Hon. Palmero F. Ebonia; it was


