Resolution No. 2023- 18

A Resolution Declaring as Operative Barangay Appropriation Ordinance No. 01, Series of 2022 of Barangay Nangcaon, Opol, Misamis Oriental entitled “An Ordinance Appropriating Funds for the period January to December 2023 in the amount of 2,657,333.00 covering Various Expenditures for Barangay Nangcaon”

WHEREAS, the Barangay Nangcaon of Opol, Misamis Oriental has submitted the Barangay Appropriation Ordinance No. 01, Series of 2022 to the Sangguniang Bayan of Opol for review;

WHEREAS, Barangay Appropriation Ordinance No. 01, Series of 2022 appropriates funds for the period of January to December 2023 in the amount of Two Million Six Hundred Fifty Seven Thousand Three Hundred Thirty Three Pesos (PhP2,657,333.00) covering various expenditures for Barangay Nangcaon, Opol, Misamis Oriental;

WHEREAS, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Municipal Budget Office, through the Municipal Budget Officer, has reviewed Barangay Appropriation Ordinance No. 01, Series of 2022 and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Nangcaon, Opol, Misamis Oriental subject however to the condition in its Letter dated December 7, 2022, stating that all disbursements of the item specified are subject to the conditions of all accounting and auditing rules and regulations and to the availability of funds;

WHEREAS, the Committee on Finance, Budget and Appropriation has recommended the approval of the Barangay Appropriation Ordinance No. 01, Series of 2022 of Barangay Nangcaon, Opol, Misamis Oriental;

WHEREAS, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;

WHEREFORE, on motion of Hon. Rhally Mae G. Piit and duly seconded by Hon. Jeffrey P. Pusan; it was


