Resolution No. 2023- 19

A Resolution Declaring as Operative Barangay Appropriation Ordinance No. 003, Series of 2022 of Barangay Bonbon, Opol, Misamis Oriental entitled "An Ordinance Realigning the amount of Php300,340.00 comprising Php189,000.00 from Unexpended Personal Services and Php111,340.00 from Various Unexpended MOOE Programs to Other Expense all under the General Fund"

WHEREAS, the Barangay Bonbon of Opol, Misamis Oriental has submitted the Barangay Appropriation Ordinance No. 003, Series of 2022 to the Sangguniang Bayan of Opol for review;

WHEREAS, Barangay Appropriation Ordinance No. 003, Series of 2022 realigns the amount of Three Hundred Thousand Three Hundred Forty Pesos (Php300,340.00) which comprises the amount of One Hundred Eighty Nine Thousand Pesos (Php 189,000.00) from the Unexpended Personal Services, and One Hundred Eleven Thousand Three Hundred Forty Pesos (Php111,340.00) from the various Unexpended Maintenance and Other Operating Expenses (MOOE) Programs to the Other Expense all under the General Fund;


WHEREAS, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Municipal Budget Office, through the Municipal Budget Officer, has reviewed Barangay Appropriation Ordinance No. 003, Series of 2022 and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Bonbon, Opol, Misamis Oriental subject however to the condition in its Letter dated December 21, 2022, stating that all disbursements of the item specified are subject to the conditions of all accounting and auditing rules and regulations and to the availability of funds;

WHEREAS, the Committee on Finance, Budget and Appropriation has recommended the approval of the Barangay Appropriation Ordinance No. 003, Series of 2022 of Barangay Bonbon, Opol, Misamis Oriental;

WHEREAS, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;


WHEREFORE, on motion of Hon. Rhally Mae G. Piit and duly seconded by Hon. Jeffrey P. Pusan; it was




