**Resolution No. 2023- 22**

**A Resolution Authorizing the Local Chief Executive, Mayor Jayfrancis D. Bago, to enter into a Contract of Pathologist Services with Dr. Ramon M. Nery, FPSP, MHA, CESO VI, for a period of One (1) Year, starting from January 1, 2023 to December 31, 2023**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

**WHEREAS**, pursuant to Section 17 (b) (2) (iii) of the Code, basic services and facilities include, but are not limited to health services which include the implementation of programs and projects on primary health care, maternal and child care, and communicable and non-communicable disease control services, access to secondary and tertiary health services; purchase of medicines, medical supplies, and equipment needed to carry out the services herein enumerated;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated January 6, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to authorize him to enter into a Contract of Pathologist Services with Dr. Ramon M. Nery, FPSP, MHA, CESO VI, for the period of one (1) year commencing from January 1, 2023 to December 31, 2023;

**WHEREAS**, a Pathologist is the one who will diagnose the presence and stage of diseases using laboratory techniques and patient specimens and study the nature, cause and development of diseases, including prevention and cure thereof;

**WHEREFORE**, on motion of Hon. Roland B. Alfeche and duly seconded by Hon. Palmero F. Ebonia; it was


