**Resolution No. 2023- 27**

**A Resolution to Request for Funding from the Department of Agriculture, represented by its Senior Undersecretary, Hon. Domingo F. Panganiban, for Road Rehabilitation of the Five (5) Hundred Meters Road leading to the Opol Public Market (with Drainage or Canal) in Barangay Poblacion, Opol, Misamis Oriental in the amount of Seven Million Five Hundred Thousand Pesos (PhP7,500,000.00), more or less**

**WHEREAS**, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the same Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

**WHEREAS**, pursuant to Section 444 (b) (4) (i) of the Code, the local government unit, through the municipal mayor, shall ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of the Code and, in addition thereto, shall ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the municipality and the province;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code likewise states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated January 5, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution requesting for funding from the Department of Agriculture, represented by its Senior Undersecretary, Hon. Domingo F. Panganiban, for the Road Rehabilitation of the Five Hundred (500) Meter Road, including Drainage or Canal, leading to the Opol Public Market in Barangay Poblacion, Opol, Misamis Oriental, in the amount of Seven Million Five Hundred Thousand Pesos (PhP7,500,000.00), more or less;



**WHEREAS**, the aforesaid project will maintain a good traffic flow and provide safety to those residents passing thereby, and help farmers to transport easily their agricultural products and goods to traders and consumers in Barangay Poblacion, Opol, Misamis Oriental;

**WHEREFORE**, on motion presented by Hon. Danilo O. Daroy and duly seconded by Hon. Roland B. Alfeche; it was


