Resolution No. 2023- 31

A Resolution Allowing the Local Chief Executive, Mayor Jayfrancis D. Bago, to accept the Unutilized Portion of Property donated by the Basak-Masayon Carp Beneficiaries Farmer Association, represented by its President, Mr. Armando Miñoza, with a Lot Area of Five Thousand Square Meters (5000 sq.m) for the Utilization and Implementation of the Integrated National Swine Production Initiatives for Recovery and Expansion Program (INSPIRE) Project in Barangay Awang, Opol, Misamis Oriental

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the same Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

WHEREAS, the Department of Agriculture (DA) has launched the Integrated National Swine Production Initiatives for Recovery and Expansion (INSPIRE) Program to implement calibrated repopulation and enhancement of the local swine industry to reinvigorate the sector's capacity in producing locally sufficient supply of hogs and pork;

WHEREAS, the Municipality of Opol is one of the beneficiaries of the 2023 Swine Clustering-Integrated National Swine Production Initiatives for Recovery and Expansion (INSPIRE) Program by the Department of Agriculture – Regional Field Office 10;

WHEREAS, Section 444 (b) (1) (vi) of the Code likewise states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated January 6, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to authorize him to accept the donation of the unutilized portion of property from the Basak-Masayon Carp Beneficiaries Farmer Association, represented by its President, Mr. Armando Miñoza, for the utilization of the subject property located at Barangay Awang, Opol, Misamis Oriental in order to implement the Integrated National Swine Production Initiatives for Recovery and Expansion Program (INSPIRE) Project;



WHEREAS, the aforesaid unutilized portion of property owned by Basak-Masayon Carp Beneficiaries Farmer Association has total lot area of Five Thousand Square Meters (5,000sq.m) which is covered by TCT No. 960138 and located in Barangay Awang, Opol, Misamis Oriental;

WHEREFORE, on motion presented by Hon. Danilo O. Daroy and duly seconded by Hon. Roland B. Alfeche; it was

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the Resolution Allowing the Local Chief Executive, Mayor Jayfrancis D.
