Resolution No. 2023- 32

A Resolution addressed to the Municipal Mayor, Atty. Jayfrancis D. Bago, requesting him to write a letter requesting the Cagayan de Oro Water District (COWD) to continue the Distribution of Water Supply to Youngsville Subdivision, Igpit, Opol, Misamis Oriental

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 (a) of the Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

WHEREAS, pursuant to Section 17 (b) (1) (v) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, maintenance of barangay roads and bridges and water supply systems;

WHEREAS, in a letter dated January 4, 2023, Mr. Ferminiano B. Galario, Jr., and Ms. Maria Olar A. Ansin, President of the Youngsville Homeowners Subdivision, Igpit, Opol, Misamis Oriental, and Zone Leader of Zone 7A, Youngsville Subdivision, Igpit, Opol, Misamis Oriental, respectively, requested assistance for their application for water connection;

WHEREAS, during the Committee Meeting of the Committee on Water, Public Works and Infrastructure last January 12, 2023, Mr. Ferminiano B. Galario corrected their request, explaining that they were not applying for water connection, and instead, raised the issue of non-distribution of water supply in Youngsville Subdivision by the Cagayan de Oro Water District (COWD) for a long period of time;

WHEREAS, the Honorable Members of the the Committee on Water, Public Works and Infrastructure agreed to pass a resolution requesting the Municipal Mayor, Atty. Jayfrancis D. Bago, to request the COWD, through a letter, for the continuation of the distribution of water supply to Youngsville Subdivision, Igpit, Opol, Misamis Oriental;

WHEREFORE, on motion presented by Hon. Danilo O. Daroy and duly seconded by Hon. Palmero F. Ebonia; it was

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the Resolution addressed to the Municipal Mayor, Atty. Jayfrancis D. Bago, requesting him to write a letter requesting the Cagayan de Oro Water District (COWD) to continue the Distribution of Water Supply to Youngsville Subdivision, Igpit, Opol, Misamis Oriental.
