Resolution No. 2023- 33

A Resolution Authorizing the Local Chief Executive, Mayor Jayfrancis D. Bago, to enter into a Contract of Service with EAAC Environmental Consulting Services, represented by its owner, Mr. Jayson Eric L. Astudillo

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;


WHEREAS, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

WHEREAS, pursuant to Section 17 (b) (1) (iii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, services and facilities related to general hygiene and sanitation, beautification, and solid waste collection;

WHEREAS, Section 444 (b) (1) (vi) of the Code states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated January 13, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to authorize him to enter into a Contract of Service with the EAAC Environmental Consulting Services, represented by its owner, Mr. Jayson Eric L. Astudillo, for the environmental services in relation to the establishment of Sanitary Landfill in Opol, Misamis Oriental with complete Environmental Compliance Certificate (ECC);

WHEREFORE, on motion of Hon. Danilo O. Daroy and duly seconded by Hon. Roland B. Alfeche; it was
