**Resolution No. 2023- 37**

**A Resolution Authorizing the Local Chief Executive, Municipal Mayor, Jayfrancis D. Bago, to Grant Financial Assistance to Rusminda C. Cagatin, a resident of Barangay Taboc, Opol, Misamis Oriental**

**WHEREAS**, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 447 (a) (1) (iv) of the Code mandates the local government unit to adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

**WHEREAS**, a Barangay Certification dated January 5, 2023 certified that Rusminda C. Cagatin is a resident of Zone 1, Taboc, Opol, Misamis Oriental, and her house and cottages were damaged by big waves during high tide last December 24, 2022. The certification further stated that it was issued upon her request for financial assistance;

**WHEREAS**, the Local Disaster Risk Reduction and Management Office (LDRRMO), through Engr. Rommel C. Lonoy, issued a Certification dated January 5, 2023, stating that Mrs. Rusminda C. Cagatin was affected by shear line in the evening of December 24, 2022, and her house was partially damaged by the said weather disturbance. The certification was issued to recommend for cash assistance amounting to Five Thousand Pesos (PhP5,000.00);

**WHEREAS**, in an urgent letter dated January 10, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution authorizing him to grant Financial Assistance amounting to Five Thousand Pesos (PhP5,000.00) to Rusminda C. Cagatin, a resident of Barangay Taboc, Opol, Misamis Oriental;

**WHEREFORE**, on the motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was


