Resolution No. 2023- 46

A Resolution to request Funding from the Office of the 2nd District Congressman, Hon. Yevgeny Vincente B. Emano, for the Construction and Installation of Solar-Powered Water System in Barangay Awang, Opol, Misamis Oriental

WHEREAS, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, pursuant to 17 (b) (2) (viii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

WHEREAS, Section 447 (a) (5) (vii) of the Code provides that local government units shall, through the Sangguniang Bayan, provide for the establishment, operation, maintenance, and repair of an efficient waterworks system to supply water for the inhabitants; regulate the construction, maintenance, repair and use of hydrants, pumps, cisterns and reservoirs; protect the purity and quantity of the water supply of the municipality and, for this purpose, extend the coverage of appropriate ordinances over all territory within the drainage area of said water supply and within one hundred (100) meters of the reservoir, conduit, canal, aqueduct, pumping station, or watershed used in connection with the water service; and regulate the consumption, use or wastage of water;

WHEREAS, in an urgent letter dated January 13, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution to request funding from the Office of the 2nd District Congressman, Hon. Yevgeny Vincente B. Emano, for the construction and installation of Solar-Powered Water System in Barangay Awang, Opol, Misamis Oriental;

WHEREAS, the Municipality of Opol wanted to immediately address the problem of water supply in Barangay Awang, Opol, Misamis Oriental;


WHEREFORE, on motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Jeffrey P. Pusan; it was


