**Resolution No. 2023- 64**

**A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAY (DPWH), THROUGH ITS DISTRICT ENGINEER, ENGR. ACHILLES B. PIMENTEL, TO FUND AND IMPLEMENT THE CONSTRUCTION OF ROAD (ACCESS ROAD LEADING TO MALANANG OSTRICH FARM) AT BARANGAY MALANANG, OPOL, MISAMIS ORIENTAL, UNDER CONSTRUCTION/IMPROVEMENT OF ACCESS ROADS LEADING TO DECLARED TOURISM DESTINATIONS (TOURISM ROAD INFRASTRUCTURE PROGRAM)**

**WHEREAS**, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

**WHEREAS**, pursuant to 17 (b) (2) (viii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

**WHEREAS**, Section 444 (b) (4) (i) of the Code states that the Municipal Mayor shall ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the municipality and the province;

**WHEREAS**, in an urgent letter dated January 20, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution requesting the Department of Public Works and Highway (DPWH), through its District Engineer, Engr. Achilles B. Pimentel to fund and implement the Construction of Road, specifically the Access Road leading to Malanang Ostrich Farm, in Barangay Malanang, Opol, Misamis Oriental, under the Construction/Improvement of Access Roads Leading to Declared Tourism Destinations (Tourism Road Infrastructure Program);

**WHEREAS**, the rural road improvement project will enable connectivity and safe, fast and dependable mobility among commuters and motorists and provides positive impact because it will give easy access to health, education and economic opportunities for both Micro, Small and Medium Enterprises (MSMEs) and small farmers;

**WHEREFORE**, on motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Jeffrey P. Puasan; it was


