Resolution No. 2023- 68

A RESOLUTION DECLARING AS PARTIALLY OPERATIVE BARANGAY APPROPRIATION ORDINANCE NO. 02, SERIES OF 2022 OF BARANGAY LUYONGBONBON, OPOL, MISAMIS ORIENTAL ENTITLED "AN ORDINANCE APPROPRIATING FUNDS FOR THE PERIOD JANUARY 2023 TO DECEMBER 2023 AMOUNTING TO FIVE MILLION SIX HUNDRED NINETY-TWO THOUSAND NINE HUNDRED EIGHTY PESOS (PHP5,692,980.00) COVERING VARIOUS EXPENDITURES FOR THE OPERATION OF BARANGAY LUYONGBONBON"

WHEREAS, the Barangay Luyongbonbon of Opol, Misamis Oriental has submitted the Barangay Appropriation Ordinance No. 02, Series of 2022 to the Sangguniang Bayan of Opol for review;

WHEREAS, Barangay Appropriation Ordinance No. 02, Series of 2022, appropriates funds amounting to Five Million Six Hundred Ninety-Two Thousand Nine Hundred Eighty Pesos (PhP5,692,980.00) for the period of January 2023 to December 2023 covering the various expenditures of Barangay Luyongbonbon, Opol, Misamis Oriental for its operation;

WHEREAS, Section 447 (a) (1) (i) of the Local Government Code mandates the Sangguniang Bayan to approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and to review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Municipal Budget Office, through the Municipal Budget Officer, has reviewed Barangay Appropriation Ordinance No. 02, Series of 2022, and found it to be within the scope of the prescribed powers of the Sangguniang Barangay of Luyongbonbon, Opol, Misamis Oriental subject however to the condition in its Letter dated January 16, 2023, stating that the 2023 Annual Budget of Barangay Luyongbonbon is partially operative as recommended and all disbursements from the 10% SK Fund must be withheld for lack of submission of the 2023 Annual Barangay Youth Investment Plan (2023 ABYIP) and its incorporation in the 2023 Annual Budget as required by the Local Government Code of 1991 (R.A. No. 7160) and all other circulars and memorandums issued by the Department of Budget and Management (DBM) and Department of the Interior and Local Government (DILG) in relation to the execution of special trust fund;

WHEREAS, the Municipal Budget Office further recommends that the 10% SK Fund shall only be executed and disbursed upon the submission, review and approval of the 2023 Annual Barangay Youth Investment Plan (2023 ABYIP);

WHEREAS, the Committee on Laws, Rules, Privileges and Human Rights has recommended the approval of the Barangay Appropriation Ordinance No. 02, Series of 2022 of Barangay Luyongbonbon, Opol, Misamis Oriental;

WHEREAS, the Sangguniang Bayan concurs with the findings and recommendations of the Committee;


WHEREFORE, on motion of Hon. Rhally Mae G. Piit and duly seconded by Hon. Roland B. Alfeche; it was


