**Resolution No. 2023- 70**

**A RESOLUTION REQUESTING A CUTTING PERMIT ON TREES AFFECTED AND AUTHORIZING THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICER, ENGR. RANDOLPH Q. HALLASGO, TO APPLY FOR A CUTTING PERMIT FROM THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) AND PHILIPPINE COCONUT AUTHORITY (PCA) FOR THE PURPOSE OF FARM-TO-MARKET LOCAL ACCESS ROAD (RAPID) PROJECT IN BARANGAY NANGCAON, OPOL, MISAMIS ORIENTAL**

**WHEREAS**, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 (a) of the Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

**WHEREAS**, pursuant to Section 17 (2) (viii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code likewise states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated January 26, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution requesting a Cutting Permit on Trees affected and authorizing the Municipal Environment and Natural Resources Officer, Engr. Randolph Q. Hallasgo, to apply for a Tree Cutting Permit from the Department of Environment and Natural Resources (DENR) and Philippine Coconut Authority (PCA) for the purpose of Farm-to-Market Local Access Road (RAPID) Project in Barangay Nangcaon, Opol, Misamis Oriental;



**WHEREAS**, a total of Forty-One (41) Trees will be affected by the Application for Tree Cutting Permit, and the affected trees are more particularly described as follows:
