Resolution No. 2023- 71

A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION (DEPED) THROUGH THE OFFICE OF SECRETARY VICE PRESIDENT SARA VICENTA Z. DUTERTE-CARPIO TO FUND THE CONSTRUCTION OF THE NEW TWO (2) CLASSROOMS FOR THE UPCOMING JUNIOR HIGH SCHOOL OF SITIO SITE, ZONE 6-BASAK, AWANG, OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 (a) of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, pursuant to 17 (b) (2) (viii) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

WHEREAS, during the 15th Regular Session of the Sangguniang Barangay of Barangay Awang, Opol, Misamis Oriental held on August 1, 2022, the Honorable Members of the Sangguniang Barangay requested the Office of the Municipal Mayor, through Resolution No. 18, Series of 2022, to allocate financial assistance for the construction of two new (2) school rooms located at Zone-6, Basak, Awang, Opol, Misamis Oriental for the upcoming Junior High School;

WHEREAS, in an urgent letter dated January 27, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to pass a Resolution requesting the Department of Education (DepEd) through the Office of Secretary Vice President Sara Vicenta Z. Duterte-Carpio to fund the construction of the two new (2) classrooms located at Sitio Site, Zone 6-Basak, Awang, Opol, Misamis Oriental for the upcoming Junior High School;

WHEREAS, the Municipality of Opol directly supports the request of Barangay Awang for the construction of the two new (2) classrooms because these classrooms are essential for the promotion and stimulation of collaborative learning that increases the students' self-awareness for them to learn more easily and effectively;


WHEREFORE, on motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Roland B. Alfeche; it was


