Resolution No. 2023- 73

A RESOLUTION APPROVING AND ADOPTING THE CAPACITY DEVELOPMENT AGENDA OF THE MUNICIPALITY OF OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 (a) of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

WHEREAS, pursuant to Executive Order No. 138 dated June 1, 2021, President Rodrigo Roa Duterte ordered the full devolution of certain functions of the Executive Branch to Local Governments, creation of a Committee on Devolution and for other purposes;

WHEREAS, Capacity Development Agenda is a comprehensive three-year plan that will guide the Local Government Unit in implementing capacity development initiatives. It specifies the following information:

1. Targeted Outcome Area/ ELA Priority and Performance Goals;
2. Current State of Capacity;
3. Desired State of Capacity (Capacity Development Objectives);
4. Capacity Development Interventions;
5. Expected Output;
6. Target of CapDev;
7. Timeframe;
8. Funding Requirements by year;
9. Process Owner/O Office Responsible; and
10. Source of Support/ Technical Assistance.

WHEREAS, the Department of the Interior and Local Government (DILG) provided a technical assistance to the Municipality of Opol in the formulation of their three (3) – year CapDev Agenda last September 29-30 and October 4, 2022 at Pearlmont Hotel, Cagayan de Oro City;

WHEREAS, the Municipality of Opol has completed its Capacity Development Agenda last December 2022;

WHEREAS, in an urgent letter dated January 27, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution approving and adopting the Capacity Development Agenda of the Municipality of Opol, Misamis Oriental;


WHEREFORE, on motion presented by Hon. Rhally Mae G. Piit and duly seconded by Hon. Roland B. Alfeche; it was


