Resolution No. 2023- 77

A RESOLUTION ALLOWING THE MUNICIPAL MAYOR, ATTY. JAYFRANCIS D. BAGO, TO GRANT FINANCIAL AID TO PRERALD T. SERRA, A RESIDENT OF BARANGAY BONBON, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 16 of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, a Barangay Certification dated January 5, 2023 certified that Mr. Prerald T. Serra who is a resident of Zone 7, Bonbon, Opol, Misamis Oriental belongs to one of the indigent families in the barangay and requesting for medical assistance for his child Samantha V. Serra;

WHEREAS, based on the medical abstract dated January 26, 2023, Samantha V. Serra was confined on January 1-4, 2023 at Madonna and Child Hospital and diagnosed with Pneumonia and Idiopathic Thrombocytopenia Purpura, and recommended for financial assistance;

WHEREAS, in an urgent letter dated February 10, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution allowing him grant financial aid to Mr. Prerald T. Serra in the amount of Ten Thousand Pesos (PhP10,000.00) as medical assistance for his daughter, Samantha V. Serra;

WHEREFORE, on motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was

RESOLVED, AS THE BODY HEREBY RESOLVES, to approve the Resolution allowing the Municipal Mayor, Atty. Jayfrancis D. Bago, to grant financial aid to Prerald T. Serra, a resident of Barangay Bonbon, Opol, Misamis Oriental in the amount of Ten Thousand Pesos (PhP10,000.00).
