Resolution No. 2023- 89

A RESOLUTION ALLOWING THE MUNICIPAL MAYOR, ATTY. JAYFRANCIS D. BAGO, TO GRANT FINANCIAL AID TO MARIEL L. TANGAL, A RESIDENT OF BARANGAY BONBON, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 16 of the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, a Barangay Certification dated January 26, 2023 certified that Mrs. Merlyn L. Tangal, who was a resident of Zone 1, Tingalan, Opol, Misamis Oriental, was known to have less monthly income and did not own any real property or business firm;

WHEREAS, based on the medical abstract dated January 17, 2023, Mrs. Merlyn L. Tangal was admitted on January 17, 2023 and discharged on January 30, 2023 at Saint Francis Doctor's Medical and Diagnostic Facility and diagnosed with Community Acquired Pneumonia, Complicated Urinary Tract Infection, Electrolyte Imbalance Hypokalemia, and Hypertensive Cardiovascular Disease;

WHEREAS, in an urgent letter dated February 16, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution allowing him grant financial aid to Ms. Mariel L. Tangal in the amount of Ten Thousand Pesos (PhP10,000.00) as financial assistance for her mother, Mrs. Merlyn L. Tangal who passed away on February 1, 2023 due to complications;

WHEREFORE, on motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was





