Resolution No. 2023- 97

A RESOLUTION APPROVING THE APPLICATION OF SPECIAL PERMIT OF THE 4 BROTHERS PRINCESS AND I TO PLACE A PARLOR GAME AND AMUSEMENT, OTHERWISE KNOWN AS "PERYA", AT ZONE 2B, PAG-IBIG CITIHOMES, MALANANG, OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code of 1991 expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 447 (a) (4) (vii) of the Code provides that the Sangguniang Bayan shall regulate activities relative to the use of land, buildings and structures within the municipality in order to promote the general welfare and for said purpose shall regulate the establishment, operation, and maintenance of entertainment or amusement facilities, including theatrical performances, circuses, billiards pools, public dancing schools, public dance halls, sauna baths, massage parlors, and other places of entertainment or amusement; regulate such other events or activities for amusement or entertainment, particularly those which tend to disturb the community or annoy the inhabitants, or require the suspension or suppression of the same; or, prohibit certain forms of amusement or entertainment in order to protect the social and moral welfare of the community;

WHEREAS, a Barangay Certification issued by Barangay Malanang, Opol, Misamis Oriental certified that it allows 4 Brothers Princess and I to place a Parlor Game and Amusement, otherwise known as "Perya", at Zone 2B, Pag-Ibig Citihomes, Malanang, Opol, Misamis Oriental and to operate the same during fiesta celebration starting from March 1, 2023 to April 10, 2023;

WHEREAS, in an endorsement letter dated February 9, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to decide the application of 4 Brothers Princess and I for the issuance of a Special Permit to place a traditional parlor game, such as bingo, color games, card games and other games, and one (1) ferris wheel at Zone 2B, Pag-Ibig Citihomes, Malanang, Opol, Misamis Oriental;

WHEREAS, during the Committee Meeting conducted by the Committee on Games and Amusements on February 22, 2023, the committee members agreed for the approval of the application of 4 Brothers Princess and I for the issuance of a Special Permit to place a Parlor Game and Amusement, otherwise known as "Perya", at Zone 2B, Pag-Ibig Citihomes, Malanang, Opol, Misamis Oriental;




WHEREFORE, in a motion presented by Hon. Palmero F. Ebonia, and duly seconded by Hon. Jeffrey P. Puasan; it was
