Resolution No. 2023- 98

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR JAYFRANCIS D. BAGO, TO ISSUE A SPECIAL PERMIT TO THE IGPIT SPORTS ARENA AND THE WILD HAWK GAMING AND AMUSEMENT OPC FOR THE CONDUCT OF 1ST SERIES OF TRADITIONAL COCKFIGHTING DERBY FUNDRAISING EVENT IN IGPIT, OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 444 (b) (3) (v) of the Local Government Code allows the Municipal Mayor to issue permits, without need of approval therefor from any national agency, for the holding of activities for any charitable or welfare purpose, excluding prohibited games of chance or shows contrary to law, public policy and public morals;

WHEREAS, the Igpit Sports Arena, in a letter dated February 17, 2023, has requested the Honorable Members of the Sangguniang Bayan of Opol to authorize the Local Chief Executive, Mayor Jayfrancis D. Bago, to issue a Special Permit for the conduct of 1st Series of Traditional Cockfighting Derby Fundraising Event in Barangay Igpit, Opol, Misamis Oriental for the months of March and April 2023, respectively;

WHEREAS, the 1st Series of Traditional Cockfighting Derby shall be scheduled on the following event:

WHEREAS, the proceeds of the fundraising event shall be used as financial support for the identified senior citizens of Opol, Misamis Oriental;


WHEREFORE, on a motion presented by Hon. Palmero F. Ebonia and duly seconded by Hon. Roland B. Alfeche; it was
