Resolution No. 2023- 99

A RESOLUTION ALLOWING THE MUNICIPAL MAYOR, ATTY. JAYFRANCIS D. BAGO, TO GRANT FINANCIAL AID TO RICHARD M. MAG-AWAY, A RESIDENT OF BARANGAY POBLACION, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TWENTY THOUSAND PESOS (PHP20,000.00)

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, based on the clinical abstract form dated February 15, 2023, Mr. Richard M. Mag-away was admitted on February 13, 2023 and discharged on February 15, 2023 at Cagayan de Oro Medical Center and diagnosed with Chronic Myelogenous Leukemia;

WHEREAS, a Certificate of Indigency dated February 21, 2023 certified that Mr. Richard M. Mag-away is a resident of Zone 3, Poblacion, Opol, Misamis Oriental and diagnosed with Myelogenous Leukemia, and is found to be eligible to avail of financial assistance as his family is not engaged in any business;

WHEREAS, the Municipal Social Welfare and Development Office, through its Social Case Study Report dated February 21, 2023, recommended that Mr. Richard M. Mag-away is qualified to avail of medical assistance from the Municipality of Opol to support his maintenance medication;

WHEREAS, in an urgent letter dated February 22, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution allowing him to grant financial aid amounting to Twenty Thousand Pesos (PhP20,000.00) to Mr. Richard M. Mag-away, a resident of Barangay Poblacion, Opol, Misamis Oriental;

WHEREFORE, on the motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was


