Resolution No. 2023- 101

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MUNICIPAL MAYOR, JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO NOEME O. SAYAGNAO, A RESIDENT OF BARANGAY LIMONDA, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 447 (a) (1) (iv) of the Code mandates the local government unit to adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, a Barangay Certification dated February 14, 2023 certified that Noeme O. Sayagnao is a resident of Zone 5, Limonda, Opol, Misamis Oriental, and a fire victim as her residential house was damaged by fire in the afternoon of December 16, 2022;

WHEREAS, the Local Disaster Risk Reduction and Management Office (LDRRMO), through Engr. Rommel C. Lonoy, issued a Certification dated February 20, 2023, stating that Noeme O. Sayagnao's residential house was totally damaged by fire in the afternoon of December 16, 2022. The certification was issued to recommend for cash assistance amounting to Ten Thousand Pesos (PhP10,000.00);

WHEREAS, in an urgent letter dated February 22, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution authorizing him to grant financial assistance amounting to Ten Thousand Pesos (PhP10,000.00) to Ms. Noeme O. Sayagnao, a resident of Barangay Limonda, Opol, Misamis Oriental;

WHEREFORE, on the motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Jeffrey P. Puasan; it was




