Resolution No. 2023- 102

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO JERICHO L. NACIONAL, A RESIDENT OF BARANGAY PATAG, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, based on the medical abstract form dated February 3, 2023, Mrs. Chona L. Nacional was admitted on January 22, 2023 and discharged on February 3, 2023 at Cagayan de Oro Polymedic Medical Plaza, Inc. and diagnosed with Sepsis Secondary to Community Acquired Pneumonia Moderate Risk, Acute Kidney Injury on Top of Chronic Kidney Disease, Urinary Tract Infection, and Acute Repunsated Heart Failure Secondary;

WHEREAS, a Certificate of Indigency dated February 23, 2023 certified that Mr. Jericho L. Nacional is a resident of P-1, B-13, L-4 MDMV, Zone 1B, Danao, Patag, Opol, Misamis Oriental and is known to have no property and is not engaged in any business in the barangay. The certification was also issued for the financial assistance of his mother, Mrs. Chona L. Nacional;

WHEREAS, in an urgent letter dated February 23, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him to grant financial assistance to Mr. Jericho L. Nacional in the amount of Ten Thousand Pesos (PhP10,000.00) for his mother, Mrs. Chona L. Nacional, who had an unpaid hospital bill amounting to Fifty-One Thousand Fifty-Seven Pesos and Ninety Centavos (PhP51,057.90);

WHEREFORE, on the motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Celestine Richie C. Caayupan; it was





