Resolution No. 2023- 107

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO AIZA L. TAPWAK, A RESIDENT OF BARANGAY IGPIT, OPOL, MISAMIS ORIENTAL IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, based on the Social Case Study Report dated November 27, 2023, Ms. Aiza L. Tapwak was diagnosed with Tetanus and other illnesses and several medicines were prescribed to her as maintenance medication. Such report likewise recommended that she is qualified to avail of medical assistance from the Municipality of Opol to support her medication;

WHEREAS, a Certificate of Indigency dated February 23, 2023 certified that Ms. Aiza L. Tapwak is a resident of Youngsville Subdivision, Igpit, Opol, Misamis Oriental and an indigent in the barangay;

WHEREAS, in an urgent letter dated March 1, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him to grant financial assistance amounting to Ten Thousand Pesos (PhP10,000.00) to Ms. Aiza L. Tapwak, a resident of Barangay Igpit, Opol, Misamis Oriental;

WHEREFORE, on a motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Eliezer A. Vacalares, Jr.; it was


