Resolution No. 2023- 131

A RESOLUTION ALLOWING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF DECEASED, HON. EDGAR V. CORTEZ, IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, a Certificate of Indigency dated March 31, 2023 stated that Princess Ann C. Janubas, is a resident of Zone 1B, Luyongbonbon, Opol, Misamis Oriental and known to be of good moral character and good social standing in the community. It further certified that she is indigent and not engaged in any business;

WHEREAS, the aforementioned certification was issued upon Princess Ann C. Janubas' request for financial assistance for her deceased father, Hon. Edgar V. Cortez;

WHEREAS, in an urgent letter dated March 31, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution allowing him to grant financial assistance to the family of deceased, Hon. Edgar V. Cortez, in the amount of Ten Thousand Pesos (PhP10,000.00) to help them defray the funeral expenses;

WHEREAS, the Municipality of Opol, through Mayor Jayfrancis D. Bago, expressed its deepest sympathy to Ms. Princess Ann C. Janubas, for the untimely demise of her father, Hon. Edgar V. Cortez, who died on March 22, 2023 due to Cerebral Infraction with antecedent cause of Chronic Hypertensive Vascular Disease and underlying cause of Non-Insulin Dependent Diabetes Mellitus;

WHEREFORE, on motion presented by Hon. Roland B. Alfeche and duly seconded by Hon. Jeffrey P. Pusan; it was


