Resolution No. 2023- 132

A RESOLUTION APPROVING THE INCIDENT ACTION PLAN FOR SEMANA SANTA (HOLY WEEK 2023) WHICH SHALL BE IMPLEMENTED ON APRIL 6 TO APRIL 9, 2023

WHEREAS, Section 16 of the Local Government Code expressly provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code states that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

WHEREAS, Section 12 (a) of the Philippine Disaster Risk Reduction and Management Act of 2010 expressly states that there shall be established an Local Disaster Risk Reduction and Management Office (LDRRMO) in every province, city and municipality, and a Barangay Disaster Risk Reduction and Management Committee (BDRRMC) in every barangay which shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction;

WHEREAS, pursuant to Section 12 (c) (1) and Section 12 (c) (2) of the Act, the municipal DRRMOs are mandated to design, program, and coordinate disaster risk reduction and management activities consistent with the National Council's standards and guidelines and to facilitate and support risk assessments and contingency planning activities at the local level;

WHEREAS, in an urgent letter dated March 31, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution approving the Incident Action Plan for Semana Santa (Holy Week) to be implemented on April 6, 7, 8, 9, 2023;

WHEREFORE, on motion presented by Kag. Roland B. Alfeche and duly seconded by Kag. Jeffrey P. Puasan; it was




