**Resolution No. 2023- 133**

**A RESOLUTION ALLOWING AND AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO DONATE FOUR (4) UNITS OF HYTERA HANDHELD RADIO TO OPOL MUNICIPAL POLICE STATION, AND THEN ENTER INTO A DEED OF DONATION REPRESENTED BY POLICE CAPTAIN RODEL T. LABADAN OF OPOL MUNICIPAL POLICE STATION, OPOL, MISAMIS ORIENTAL**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated April 5, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him to donate four (4) units of Hytera Handheld Radio to Opol Municipal Police Station by executing a Deed of Donation between him and the Opol Municipal Police Station, represented by its Chief of Police, Police Captain Rodel T. Labadan;



**WHEREAS**, the four (4) units of Hytera Handheld Radio are more particularly described below:


