Resolution No. 2023- 135

A RESOLUTION CONCURRING TO THE APPOINTMENT OF MS. MALYN B. LUMACAD AS THE MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICER I) IN THE LOCAL GOVERNMENT UNIT OF OPOL

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 443 (d) of the Code provides that heads of departments and offices shall be appointed by the municipal mayor with the concurrence of the majority of all the Sangguniang bayan members, subject to civil service law, rules and regulations. The Sangguniang bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

WHEREAS, on March 16, 2023, Ms. Malyn B. Lumacad was appointed as the Municipal Government Department Head I (Municipal Social Welfare and Development Officer I) at the Office of the Municipal Social Welfare and Development, with Salary Grade of 24, under a permanent status;

WHEREAS, in a letter dated March 30, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution concurring to the appointment of Ms. Malyn B. Lumacad as the Municipal Government Department Head I (Municipal Social Welfare and Development Officer I) in the Municipality of Opol;


WHEREFORE, in a motion presented by Hon. Rhally Mae G. Piit, and duly seconded by Hon. Jeffrey P. Pusan; it was

RESOLVED, AS THE BODY HEREBY RESOLVES, to approve the Resolution Concurring to the appointment of Ms. Malyn B. Lumacad as the Municipal Government Department Head I (Municipal Social Welfare and Development Officer I) in the Local Government Unit of Opol.
