**Resolution No. 2023- 139**

**A RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF MALAYAT FARMERS ASSOCIATION IN THE MUNICIPALITY OF OPOL, MISAMIS ORIENTAL**

**WHEREAS**, Section 16 of the Local Government Code expressly provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

**WHEREAS**, Section 34 of the Code states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2022-083 dated June 15, 2022 with a subject, namely, Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

**WHEREAS**, on March 29, 2023, the Malayat Farmers Association, through its President, Jenifer G. Dominguez, has signified its intention for accreditation in the Municipality of Opol, Misamis Oriental to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

**WHEREAS**, upon review of the application for accreditation, the Malayat Farmers Association has satisfactorily complied with the legal requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC No. 2022-083;

**WHEREFORE**, in a motion of Hon. Danilo O. Daroy and duly seconded by Hon. Jeffrey P. Pusan; it was

**RESOLVED, AS IT IS HEREBY RESOLVED**, to approve the Resolution Approving and Granting the Malayat Farmers Association in the Municipality of Opol, Misamis Oriental.


