Resolution No. 2023- 141

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD), REPRESENTED BY ITS REGIONAL DIRECTOR, ARIEL B. ABRAGAN, TO UNDERTAKE THE PREPARATION/ UPDATING/ REFINEMENT OF THE COMPREHENSIVE LAND USE PLAN AND ZONING ORDINANCE (CLUP/ZO) OF THE MUNICIPALITY OF OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 20 (c) of the Code provides that local government units shall, in conformity with existing laws, continue to prepare their respective comprehensive land use plans enacted through zoning ordinances which shall be the primary and dominant bases for the future use of land resources: Provided. That the requirements for food production, human settlements, and industrial expansion shall be taken into consideration in the preparation of such plans;

WHEREAS, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated April 13, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him enter into a Memorandum of Agreement (MOA) with the Department of Housing Settlements and Urban Development (DHSUD), represented by its Regional Director, Ariel B. Abragan, to undertake the Preparation, Updating, and Refinement of the Comprehensive Land Use Plan and Zoning Ordinance (CLUP/ZO) of the Municipality of Opol, Misamis Oriental;

WHEREAS, the current Comprehensive Land Use Plan and Zoning Ordinance of the Municipality of Opol needs to be prepared, updated and refined in order to guide and regulate the land development and utilization of the municipality;

WHEREFORE, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Roland B. Alfeche; it was


