Resolution No. 2023- 142

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD), REPRESENTED BY ITS DEPARTMENT SECRETARY, JOSE RIZALINO L. ACUZAR, TO DEVELOP HOUSING PROJECTS FOR THE BENEFIT OF THE RESIDENTS OF OPOL, MISAMIS ORIENTAL

WHEREAS, Section 9, Article XIII of the 1987 Philippine Constitution expressly declares that the State shall, by law, and for the common good, undertake, in cooperation with the private sector, a continuing program of urban land reform and housing which will make available at affordable cost, decent housing and basic services to under-privileged and homeless citizens in urban centers and resettlement areas;

WHEREAS, Section 16 of the Local Government Code states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code provides that Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated therein;

WHEREAS, pursuant to Section 2 of R.A. No. 11201, otherwise known as the "Department of Human Settlements and Urban Development Act", the State shall encourage on-site development in the implementation of housing programs and shall promote the creation of new settlements and development of sustainable urban renewal programs while guaranteeing the preservation of agricultural lands necessary for food security;

WHEREAS, the Department of Human Settlements and Urban Development (DHSUD), through its government housing project namely, the Pambansang Pabahay Para sa Pilipino (4PH) Program, aims to provide housing to over six million families by 2028 throughout the Philippines;

WHEREAS, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated April 14, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him enter into a Memorandum of Understanding (MOU) with the Department of Housing Settlements and Urban Development (DHSUD), represented by its Department Secretary, Jose Rizalino L. Acuzar, to develop Housing Projects for the benefit of the residents of Opol, Misamis Oriental;


WHEREFORE, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Roland B. Alfeche; it was


