**A RESOLUTION ALLOWING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF DECEASED, ELSIE B. GALLEGO, IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00)**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code likewise provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

**WHEREAS**, in an urgent letter dated April 20, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan to pass a Resolution allowing him to grant financial assistance to the family of deceased, Elsie B. Gallego, in the amount of Ten Thousand Pesos (PhP10,000.00) to help them defray the funeral expenses;


**WHEREAS**, the Municipality of Opol, through Mayor Jayfrancis D. Bago, expressed its deepest sympathy to Ms. Cherryl G. Magnetico, for the untimely demise of her mother, Elsie B. Gallego, who died on April 15, 2023 due to to Non-Ketotic Coma with antecedent cause of Non-Insulin Dependent Mellitus based on the Certificate of Death dated April 17, 2023;
