Resolution No. 2023- 147

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES, REPRESENTED BY ITS CAPISTRANO BRANCH HEAD, AVP LIGAYA L. PADILLA, FOR THE INSTALLATION OF A THRU-THE-WALL ATM AT THE MUNICIPAL HEALTH CENTER OF OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated therein;

WHEREAS, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated April 20, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him enter into a Memorandum of Agreement (MOA) with the Land Bank of the Philippines, represented by its Capistrano Branch Head, AVP Ligaya L. Padilla, for the installation of a Thru-the-Wall ATM at Municipal Health Center of Opol, Barangay Taboc, Opol, Misamis Oriental;

WHEREAS, the Municipality of Opol has allowed the Land Bank of the Philippines to utilize a two (2) square meter space of the Municipal Health Center of Opol for the installation of one (1) unit of ATM Booth;

WHEREFORE, in a motion presented by Hon. Roland B. Alfeche, and duly seconded by Hon. Palmero F. Ebonia; it was


