A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, ATTY. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE UCPB SAVINGS BANK, INC., REPRESENTED BY ITS BRANCH BANKING DIVISION HEAD, MR. PATRICK M. GONZALEZ, FOR THE ARRANGEMENT OF THE KASAMA MO SALARY LOAN (KMSL) PROGRAM AVAILABLE TO THE LGU EMPLOYEES OF OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

WHEREAS, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated April 19, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him enter into a Memorandum of Agreement (MOA) with the UCPB Savings Bank, represented by its Branch Banking Division Head, Mr. Patrick M. Gonzalez, for the arrangement of the Kasama Mo Salary Loan (KMSL) Program available to the employees of the Municipality of Opol;

WHEREAS, the UCPB Savings Bank, Inc. offers an Extended Salary Loan with Mortality Redemption Insurance (MRI) under its Kasama Mo Salary Loan (KMSL) Program through payroll deductions;

WHEREFORE, in a motion presented by Hon. Rhally Mae G. Piit, and duly seconded by Hon. Palmero F. Ebonia; it was


RESOLVED, AS THE BODY HEREBY RESOLVES, to approve the Resolution Authorizing the Local Chief Executive, Atty. Jayfrancis D. Bago, to enter into a Memorandum of Agreement with the UCPB Savings Bank, Inc., represented by its Branch Banking Division Head, Mr. Patrick M. Gonzalez, for the arrangement of the Kasama Mo Salary Loan (KMSL) Program available to the LGU employees of Opol, Misamis Oriental.
