Resolution No. 2023- 149

A RESOLUTION RECOGNIZING THE SECOND THURSDAY OF JANUARY OF EVERY YEAR AS "NATIONAL BAPTIST DAY", A SPECIAL DAY OF CELEBRATION AND COMMEMORATION FOR THE BAPTIST COMMUNITY

WHEREAS, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code;

WHEREAS, Republic Act No. 11897, otherwise known as the "National Baptist Day Act", declared the Second Thursday of January of every year as Special Working Holiday to be known as "National Baptist Day";

WHEREAS, in an urgent letter dated April 20, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution recognizing the second Thursday of January of every year as "National Baptist Day", a special day of celebration and commemoration for the community of Baptists;


WHEREAS, during the committee meeting conducted on April 26, 2023, the Senior Pastor of Lapasan Baptist Church said that the purpose of such request was for the Baptist people to partner with the local government units and to be a blessing through service to the community by ministering the constituents continuously;

WHEREFORE, in a motion presented by Hon. Rhally Mae G. Piit, and duly seconded by Hon. Roland B. Alfeche; it was


