**Resolution No. 2023- 153**

**A RESOLUTION APPROVING THE APPLICATION OF SPECIAL PERMIT OF MR. EDWIN L. MADRIDANO IN THE INSTALLATION AND OPERATION OF FUNFAIR (PERYAHAN) BEGINNING ON APRIL 20, 2023 UNTIL MAY 20, 2023 AT BARANGAY LUYONGBONBON, OPOL, MISAMIS ORIENTAL**

**WHEREAS**, Section 16 of the Local Government Code of 1991 expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 447 (a) (4) (vii) of the Code provides that the Sangguniang Bayan shall regulate activities relative to the use of land, buildings and structures within the municipality in order to promote the general welfare and for said purpose shall regulate the establishment, operation, and maintenance of entertainment or amusement facilities, including theatrical performances, circuses, billiards pools, public dancing schools, public dance halls, sauna baths, massage parlors, and other places of entertainment or amusement; regulate such other events or activities for amusement or entertainment, particularly those which tend to disturb the community or annoy the inhabitants, or require the suspension or suppression of the same; or, prohibit certain forms of amusement or entertainment in order to protect the social and moral welfare of the community;

**WHEREAS**, a Barangay Clearance dated April 24, 2023 was issued by Barangay Luyongbonbon, Opol, Misamis Oriental to Mr. Edwin L. Madridano for the operation of his Funfair (Peryahan) at Zone 6, Luyongbonbon, Opol, Misamis Oriental;

**WHEREAS**, in an urgent letter dated April 27, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to act upon the application of Mr. Edwin L. Madridano for the issuance of a Special Permit to place and operate at Barangay Luyongbonbon, Opol, Misamis Oriental a Funfair (Peryahan);



**WHEREFORE**, in a motion presented by Hon. Palmero F. Ebonia, and duly seconded by Hon. Roland B. Alfeche; it was


