Resolution No. 2023- 154

A RESOLUTION APPROVING THE APPLICATION OF SPECIAL PERMIT OF THE LURISH AMUSEMENT FAIR TO PLACE AN AMUSEMENT FAIR, OTHERWISE KNOWN AS "PERYAHAN", AT BARANGAY BARRA, OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code of 1991 expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 447 (a) (4) (vii) of the Code provides that the Sangguniang Bayan shall regulate activities relative to the use of land, buildings and structures within the municipality in order to promote the general welfare and for said purpose shall regulate the establishment, operation, and maintenance of entertainment or amusement facilities, including theatrical performances, circuses, billiards pools, public dancing schools, public dance halls, sauna baths, massage parlors, and other places of entertainment or amusement; regulate such other events or activities for amusement or entertainment, particularly those which tend to disturb the community or annoy the inhabitants, or require the suspension or suppression of the same; or, prohibit certain forms of amusement or entertainment in order to protect the social and moral welfare of the community;

WHEREAS, a Certification dated April 24, 2023 was issued by Barangay Barra, Opol, Misamis Oriental to Luz Pantalita, owner of the Lurish Amusement Fair, allowing her to operate an Amusement Fair or "Peryahan" at Johndorf Plaza, Zone 9, Barra, Opol, Misamis Oriental for the period of May 15, 2023 to June 30, 2023 in celebration of the Barangay Barra Fiesta 2023;

WHEREAS, in a letter received on April 27, 2023, the Lurish Amusement Fair applied to the Office of the Sangguniang Bayan of Opol, through Vice Mayor Danilo E. Daroy, Jr., for the issuance of a Special Permit to place at Barangay Barra, Opol, Misamis Oriental an Amusement Fair or "Peryahan" in celebration of barangay fiesta;

WHEREAS, during the Committee Meeting conducted by the Committee on Games and Amusements on May 4, 2023, the committee members agreed to approve the application of Lurish Amusement Fair for the issuance of a Special Permit to place a mini carnival, otherwise known as "Peryahan", at Barangay Barra, Opol, Misamis Oriental;

WHEREAS, the Lurish Amusement Fair will install a mini carnival at Johndorf Plaza, Zone 9, Barangay Barra, Opol, Misamis Oriental and provide the following games: Lovers Wheel; Kiddie Car; Super Swing; Drop Ball; Three Balls; Raffle Toy Card; Color Game; Drop Coin; Ring Game; Shooting Gallery; Videoke; Rolling Ball; and Bingo;


WHEREFORE, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Palmero F. Ebonia; it was
