Resolution No. 2023- 156

A RESOLUTION ALLOWING MAYOR JAYFRANCIS D. BAGO TO ENTER INTO A LETTER OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE – PHILIPPINE RICE RESEARCH INSTITUTE, REPRESENTED BY ITS BRANCH DIRECTOR, MR. CEASAR JOVENTINO M. TADO, PHD, FOR THE IMPLEMENTATION OF RCEF SEED AND EXTENSION PROGRAMS FOR THE RICE FARMERS OF OPOL, MISAMIS ORIENTAL

WHEREAS, Section 16 of the Local Government Code expressly states every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 of the Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, pursuant to Section 17 (b) (1) (i) of the Code, the local government units are mandated to provide agricultural support services which include planting materials distribution system and operation of farm produce collection and buying stations;

WHEREAS, Section 444 (b) (1) (vi) of the Code states that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, in an urgent letter dated May 5, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution allowing him to enter into a Letter of Agreement with the Department of Agriculture – Philippine Rice Research Institute, represented by its Branch Director, Mr. Ceasar Joventino M. Tado, PhD, for the implementation of RCEF Seed and Extension Programs for the rice farmers in the Municipality of Opol, Misamis Oriental;

WHEREAS, the DA-PhilRice seeks to implement one or a combination of the following projects: 1) Distribution of Certified Seeds (CS) of Inbred Rice Varieties and IEC Materials; 2) PalaySikatan: The RCEF Technology Demonstration of Recommended Inbred Rice Varieties and Mechanized Farming System; and 3) Development of Fertilizer Recommendations for Provinces under the RCEF Seed Program;

WHEREFORE, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Palmero F. Ebonia, Jr.; it was


RESOLVED, AS THE BODY HEREBY RESOLVES, to approve the Resolution allowing Mayor Jayfrancis D. Bago to enter into a Letter of Agreement with the Department of Agriculture – Philippine Rice Research Institute, represented by its Branch Director, Mr. Ceasar Joventino M. Tado, PhD, for the implementation of RCEF Seed and Extension Programs for the rice farmers of Opol, Misamis Oriental.
