**Resolution No. 2023- 159**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JAYFRANCIS D. BAGO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT UNIT OF ALUBIJID, REPRESENTED BY ITS LOCAL CHIEF EXECUTIVE, HON. EMMANUEL L. JAMIS, ALLOWING THE MUNICIPALITY OF OPOL TO DISPOSE OF ITS RESIDUAL WASTE IN THE LATTER'S SANITARY LANDFILL PENDING THE COMPLETION OF OPOL'S SANITARY LANDFILL**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 17 of the Code provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated therein;

**WHEREAS**, pursuant to Section 17 (b) (2) (vi) of the Code, local government units are mandated to provide basic services and facilities such as, but not limited to, solid waste disposal system or environmental management system and services or facilities related to general hygiene and sanitation;

**WHEREAS**, Section 444 (b) (1) (vi) of the Code mandates that the Municipal Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the municipal government, and in this connection, shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in an urgent letter dated May 17, 2023, the Local Chief Executive, Mayor Jayfrancis D. Bago, requested the Honorable Members of the Sangguniang Bayan of Opol to issue a Resolution authorizing him to enter into a Memorandum of Agreement with the Municipality of Alubijid, represented by its Local Chief Executive, Hon. Emmanuel L. Jamis, allowing the Municipality of Opol to dispose of its residual waste into the Sanitary Landfill of Alubijid pending the completion of the Opol Sanitary Landfill.

**WHEREFORE**, in a motion presented by Hon. Danilo O. Daroy, and duly seconded by Hon. Roland B. Alfeche; it was




**RESOLVED, AS THE BODY HEREBY RESOLVES,** to approve the Resolution Authorizing the Local Chief Executive, Hon. Jayfrancis D. Bago, to enter into a Memorandum of Agreement with the Local Government Unit of Alubijid, represented by its Local Chief Executive, Hon. Emmanuel L. Jamis, allowing the Municipality of Opol to dispose of its residual waste in the latter's sanitary landfill pending the completion of Opol's Sanitary Landfill.
