**Resolution No. 2023- 160**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR JAYFRANCIS D. BAGO, TO ISSUE A SPECIAL PERMIT TO THE IGPIT SPORTS ARENA AND WILD HAWK GAMING AND AMUSEMENT OPC FOR THE CONDUCT OF 1<sup>ST</sup> AND 2<sup>ND</sup> SERIES OF COCKFIGHTING DERBY FUNDRAISING EVENTS IN THE MONTHS OF JULY AND AUGUST 2023 AT BARANGAY IGPIT, OPOL, MISAMIS ORIENTAL**

**WHEREAS**, Section 16 of the Local Government Code expressly states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 444 (b) (3) (v) of the Local Government Code allows the Municipal Mayor to issue permits, without need of approval therefor from any national agency, for the holding of activities for any charitable or welfare purpose, excluding prohibited games of chance or shows contrary to law, public policy and public morals;

**WHEREAS**, the Igpit Sports Arena and Wild Hawk Gaming and Amusement OPC, in both letters dated May 9, 2023, had requested the Honorable Members of the Sangguniang Bayan of Opol to authorize the Local Chief Executive, Mayor Jayfrancis D. Bago, to issue a Special Permit for the conduct of 1<sup>st</sup> and 2<sup>nd</sup> Series of Cockfighting Derby Fundraising Events in Barangay Igpit, Opol, Misamis Oriental for the months of July and August 2023;

**WHEREAS**, the 1<sup>st</sup> and 2<sup>nd</sup> Series of Cockfighting Derby shall be scheduled on the following events:

**WHEREFORE**, on a motion presented by Hon. Palmero F. Ebonia and duly seconded by Hon. Roland B. Alfeche; it was


